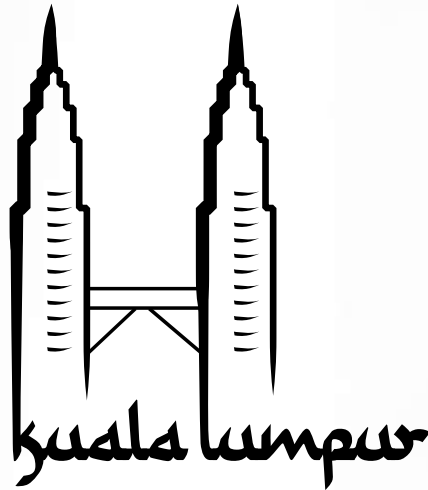

Keynote Speaker Profile

Professor Josh Lerner



Josh Lerner is the Jacob H. Schiff Professor of Investment Banking at Harvard Business School, with a joint appointment in the Finance and the Entrepreneurial Management Areas. He graduated from Yale College with a Special Divisional Major that combined physics with the history of technology. He worked for several years on issues concerning technological innovation and public policy, at the Brookings Institution, for a public-private task force in Chicago, and on Capitol Hill. He then earned a Ph.D. from Harvard's Economics Department.

Much of his research focuses on venture capital and private equity organizations. (This research is collected in three books, *The Venture Capital Cycle*, *The Money of Invention*, and the forthcoming *The Secret Sauce*.) He also examines government policies towards innovation and entrepreneurship. (The research is discussed in the books *Innovation and Its Discontents*, *Boulevard of Broken Dreams*, and *The Comingled Code*.) He founded, raised funding for, and organizes two groups at the National Bureau of Economic Research: *Entrepreneurship and Innovation Policy* and *the Economy*. He also founded the *Private Capital Research Institute*, a non-profit that seeks to encourage and disseminate research about venture capital and private equity, a successor to a multi-year study he led for the World Economic Forum.


